

## \*\*\*PUBLIC NOTICE\*\*\*PUBLIC NOTICE\*\*\*

- 1. Public buyers at the Banc Repo sale must purchase an annual \$350 membership in order to receive a bidder badge.
- 2. Payments need to be in the form of a MONEY ORDER or CASHIERS CHECK ONLY.
- 3. WE NO LONGER ACCEPT CASH FOR ANY PAYMENT.
- 4. The successful bidder is required to pay \$500 non-refundable deposit prior to receiving your bidder's badge. Once a purchase is made another \$500 non-refundable deposit is required to continue bidding. Public premium of \$250 will be manually added to the purchase price in addition to a buy fee.
- 5. Public bidder MUST wear a pink vest for safety and to be properly identified. Those not wearing the safety vest and bidder badge will not be allowed to enter the sale.
- 6. Membership card will expire on December 31st of the year it is issued. Card may be used an unlimited number of times during the year it is valid.
- 7. ALL THOSE WISHING TO ENTER THE SALE ARENA TO PURCHASE VEHICLES WILL NEED TO HAVE A MEMBERSHIP AND BIDDER BADGE. Only those with badges will be permitted in the arena.
- 8. No one under the age of 18 is permitted in the arena. Public viewing hours without a paid membership are Mondays 9:00AM-4:00PM
- 9. Tuesdays viewing (ONLY with a paid membership) begins at 8:00 AM.
- 10. Membership card and a valid driver's license must be presented every sale to receive a bidder badge.
- 11. Membership card is NOT REFUNDABLE OR TRANSFERABLE.
- 12. IF bids: Your IF offer is conditional upon the seller agreeing to sell at that offered price. Accepted IF bids must be paid in full (including buyers fee) by 5:00PM on Thursday. IF bids are binding until 5:00PM day of sale. TRA IF bids are binding until 12:00pm Wednesday.
- 13. The person whose bid number appears on the paperwork MUST sign the paperwork in the office immediately following the winning bid.
- 14. Title will be made out to individual whose name is listed as purchaser on paperwork ONLY. No exceptions.
- 15. All vehicles are sold strictly AS-IS.
- 16. Full payment must be received by 5:00PM on Thursday of the week unit was purchased. Failure to pay the remaining balance by Thursday at 5:00PM will result in revocation of membership.
- 17. **NO CASH, personal checks, credit cards, or debit cards accepted!** We only accept MONEY ORDERS or CERTIFIED funds only. You must have a valid government-issued photo ID when making payment.
- 18. Cashier's checks must be made payable to Manheim Ohio. Remitter must be the person whose name appears on the deal, or Remitter can be left blank.
- 19. Temporary tags can be obtained with a bill of sale at deputy registration locations.
- 20. Public wishing to view the sale of their repossession may view the sale, but not bid without paying a \$500 non-refundable deposit, only after surrendering a valid driver's license and receiving a visitor's badge and safety vest. License will be returned upon the return of the visitor's badge and safety vest.
